

Resource consents - how can you keep your costs down?

When developing land, it is critical to understand the costs associated with the project and ways you can manage or reduce them. You may not realise that you do have some control over reducing your Council resource consent processing fees- but how?

1 Engage a planner

Planners are experts in resource consents, and will identify risks, opportunities and ways to make the process more efficient. A skilled planner will:

- advise you on the district and regional plan provisions, ensuring your development is consistent with what these expect.
- advise you of the risks, as they understand Council's processes and expectations. Some planners also process resource consents for Councils, meaning they understand both sides of the process.
- identify other necessary specialists to provide additional assessments to support your resource consent application, e.g. flooding, land contamination.
- manage the resource consent process on your behalf, including liaising with other specialists and the Council, freeing you up to plan your project.
- resolve issues quickly as they understand the issues and what Council staff are really asking.

2 Find the right team to assist

It's important to find the right team of specialists to assist you and your specific project. You want to engage specialists who are qualified and have experience in your specific project type - not just the "in-house" person. It's important to get the right fit for you and your project. Finding the right team means:

 having a team of specialists who have experience and knowledge in the type of project you're undertaking and can achieve your goals. This is in contrast to just engaging the "in-house" specialist as they may lack the knowledge and experience you need to make your project successful.
